# Clark County Department of Aviation | LAS Airport Newsletter Giveaway Official Rules

# NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.

These official rules ("Rules") apply to this contest ("Contest") sponsored by Harry Reid International Airport ("LAS"), owned and operated by the Clark County Department of Aviation ("CCDOA"), and conducted via LAS's official Instagram social media platform. Entry into this Contest constitutes full and unconditional agreement to these Rules.

### 1.Binding Agreement

In order to enter the Contest, you ("Contestant") must agree to these Rules. The Rules consist of the terms and conditions on this page ("Contest Materials"). These Rules will form a legally binding agreement ("Agreement") with respect to this Contest, please read them carefully. Contestants must agree to these Rules to be eligible for the Contest.
